



# Archer Represents Chinese Companies in First-of-Its-Kind U.S. Bankruptcy Filing

Chinese companies that make and sell solar energy panels are seeking bankruptcy court protection of their U.S. assets – primarily about 275,000 photovoltaic panels warehoused in New Jersey – in what is believed to be the first ever filing by debtors from mainland China under Chapter 15 of the U.S. Bankruptcy Code.

Attorneys from Archer's Bankruptcy Law Practice filed petitions in U.S. Bankruptcy Court in Camden, N.J., under Chapter 15, which governs U.S. insolvency proceedings of foreign companies. The debtors – Zhejiang Topoint Photovoltaic Co. Ltd. and three affiliates: Zhejiang Jiutai New Energy Co. Ltd., Zhejiang Yutai Solar Materials Co. Ltd., and Zhejiang Willsolar Photoelectric Materials Co. Ltd. – are based in Haining City, Zhejiang Province, where they are currently debtors in bankruptcy proceedings before a Chinese court which are being



administered on a consolidated basis.

The four U.S. cases will also be jointly administered under an order signed by the Honorable Gloria M. Burns, Chief Judge of U.S. Bankruptcy Court for the District of New Jersey. Further hearings on recognition of the foreign proceedings are expected in August. In the meantime, Chief Judge Burns has ordered that the Debtors

are entitled to inspect, safeguard and inventory the U.S. assets and that “all rights of transferring, encumbering, or otherwise disposing of the Debtors’ assets are hereby suspended until further Order of the Court.”

The Debtors ran into financial difficulties in the wake of the 2008 global economic crisis and subsequent downturn in the solar industry, as global demand failed to keep pace with expectations and inventory. The solar panels in question were shipped to New Jersey in 2011 and 2012 while the company was implementing a strategy to increase its U.S. sales, but have remained in a Bridgeton, N.J., warehouse.
