Paycheck Protection Program (PPP) Round 2: *Assessing and Accessing Potential Benefits for Your Business*

On December 27th, the Economic Aid to Hard-Hit Small Businesses, Nonprofits, and Venues Act became law. As part of their ongoing legislative response to the COVID-19 pandemic, Congress has made an additional \$284 billion available to small businesses through a reauthorization of the Paycheck Protection Program. However, this money is being made available to a smaller group of potential recipients and some of the program's terms, including those applicable to existing PPP borrowers, have changed in substantial ways. In this session, the panelists will discuss:

- How the new legislation impacts existing PPP borrowers, including those that have already received full loan forgiveness
- The additional reauthorization of - and funding provided to - the PPP
- How this next round of PPP will differ from the first round of the program
- The availability of new, increased existing or second draw loans to small businesses and revised eligibility criteria for same
- Congress' latest attempt to direct PPP funds to small businesses and certain disadvantaged borrowers
- What hasn't changed and why some borrowers may be reluctant to apply to the program or seek second draw loans.

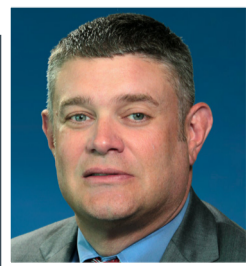
