Roth is admitted to practice in New Jersey and New York and is also admitted to the U.S. District Courts for New Jersey, Southern New York, Eastern New York, Northern New York and Western New York, as well as the Second Circuit.

Since the early 1980s, Roth has been representing clients throughout New York and New Jersey in a range of commercial and civil matters, including breach of contract, fraud and breach of fiduciary duty, among others.

"I've been practicing law for nearly 40 years and take pride in serving as a true client advocate," she said. Over the past two years, Archer has hired more than 22 lateral attorneys in its business litigation and corporate practices, according to Gibson, with an emphasis on estates and trusts, mergers and acquisitions and labor and employment, in addition to other practice areas.

"The firm's strategic growth is focused on increasing our breadth and depth of services in New York and north New Jersey," he said. "Fostering the firm's extensive business litigation experience and building out our transactional practices is a priority."

Joining the firm's business litigation group are Alexis M. Way and Robert J. Faugno. Way is based in Voorhees and Faugno is based out of the firm's Hackensack, New Jersey office.

Both Way and Faugno handle a variety of matters including trademark infringement, non-compete agreements, breach of contract and products liability and estate distribution, among others. Way received her law degree from Rutgers Law School, and Faugno received his from Seton Hall University School of Law.

In addition to Way and Faugno, the firm brought on Jason Zoranski as an associate in its business counseling group in Voorhees. Zoranski focuses his practice on advising clients on federal and state income tax issues. He counsels corporations, limited liability companies, partnerships and tax-exempt organizations

Zoranski's practice also includes guiding clients in corporate transactions, such as mergers and acquisitions, asset purchases, stock purchases, restructurings and business dissolutions, among other matters.
