He is currently a co-chair of the Bergen County Judicial and Prosecutorial Appointments Committee, which reviews applicants for appointment and reappointment to the Superior Court in Bergen County. Serving as an advocate on behalf of the members of the BCBA, on September 24, 2024 Andrew appeared before the New Jersey Supreme Court, advocating for the reversal of Advisory Committee on Professional Ethics Opinion 735.

Throughout his career, Andrew has demonstrated dedication to public service, including his work for over a decade on the N.J. Supreme Court Committee on Character, which reviews applications for admission to the New Jersey Bar, and his service on the N.J. Supreme Court District IIB Ethics Committee.
