

Peg Callahan – Kuskin is the Key Lobbyist for the PA Dental Association's Recent Legislative Victory

On October 22, 2024, Governor Josh Shapiro signed House Bill 1664 into law as Act 58 of 2024, which was a top legislative priority this Session for the Pennsylvania Dental Association, a client of Archer Public Affairs ("APA"). In Pennsylvania, APA Director, Peg Callahan – Kuskin, has been the key lobbyist for the Pennsylvania Dental Association, which has over 8,000 Members. This legislation is a victory for dentists and their patients, ensuring that dental care remains accessible and affordable across the Commonwealth. This Act provides that insurers may no longer limit reimbursement methods exclusively to electronic credit cards – which often carry high transaction fees – and must instead offer a variety of reimbursement options so providers can choose the method best suited to them. Archer Public Affairs is a subsidiary of Archer & Greiner.

The new law was passed as H.B. 1664, which was introduced by Rep Scott to apply to dental practices. It was later amended to add language from Rep Venkat's H.B. 1867 to make the legislation apply broadly to all health care practices. According to a ProPublica article, almost 60% of medical practices said they were compelled to pay fees for electronic payment at least some of the time. These fees can also cost larger medical practices \$1 million a year, and small clinics can lose as much as \$100,000 due to the fees.

Peg worked with the Republican leadership in the Pennsylvania Senate as a legislative specialist and has served as a special assistant to the Pennsylvania Secretary for Commerce.
