## **Overview**

Carlton focuses his practice on commercial and complex litigation matters. Carlton also managed court supervised agreements to resolve decades-long structural and operational challenges that exposed the government to potentially significant financial liability. During his tenure with the Law Department, Carlton handled all of the litigation matters arising out of the Republican National Convention (RNC 2000). He also represented the City in general liability and tax matters and provided advice and counsel to several City Solicitors to help resolve organizational challenges within the Law Department itself.
