Green, of Cherry Hill, is Chair of the firm’s Real Estate Department and its Financial Services Practice Group. He represents real estate developers, builders, financial institutions, investors and brokers, as well as industrial, commercial and professional businesses in a wide range of commercial matters. Fogler, also of Cherry Hill, is
