In addition, the board plays an active role in the ongoing development of the Camden Ray and Joan Kroc Community Center, slated for the area of 22nd Street and Harrison Avenue in the Cramer Hill section of Camden. Groundbreaking is expected late this year.

The estate of philanthropist Joan Kroc, wife of McDonald's founder Ray Kroc, has provided the Camden Citadel chapter with a \$54 million grant to build and operate the 120,000-square-foot community center, which will
