



# Jeffrey Kolansky Appointed to Chamber Orchestra of Philadelphia Board

Attorney **Jeffrey M. Kolansky** has been appointed to the Board of Directors of the Chamber Orchestra of Philadelphia, a 33-member ensemble that performs locally, nationally and internationally.

Kolansky brings a long history of Philadelphia civic involvement to the orchestra. A former longtime attorney with the Philadelphia District Attorney's Office, Kolansky is a Philadelphia resident and Managing Partner of the Philadelphia office of Archer, P.C. Chamber orchestras such as Philadelphia's are smaller than today's full-sized orchestras and often perform works by composers who wrote with a chamber orchestra in mind, including Baroque and Classical period composers such as Bach, Handel, Vivaldi, Haydn, Mozart, Beethoven, Schubert and their contemporaries.

The Chamber Orchestra of Philadelphia is a founding resident company of the Kimmel Center for the Performing Arts and performs in the Center's intimate, 600-seat Perelman Theater. Founded in 1964, the Orchestra today is led by Ignat Solzenitsyn, an acclaimed pianist and conductor and son of the famed Russian author. Solzenitsyn is in his fifth season as the Orchestra's Music Director, having served as Principal Conductor for the preceding six years. To date, the Orchestra has more than 70 commissions and première performances to its credit, including seven works written since 2000.
