



# Frances McElhill to Present at Symposium on Managing Nonprofits Through Tough Times

**Frances A. McElhill and Ritter will also discuss the effect on balance sheets of UPMIFA, which updates existing investment management guidelines for endowment funds held by charitable institutions.

McElhill, a resident of Moorestown, focuses her practice in the area of tax-exempt organizations such as hospitals, colleges and universities, as well as smaller nonprofits such as multi-program social service providers, churches, arts and cultural groups and civic organizations. She also serves as outside counsel to major private and private operating foundations. She has served as bond counsel for tax-exempt financings for Section 501(c)(3) organizations and multi-family and single-family housing projects, as well as representing underwriters, trustees and borrowers in these financings. She has also represented nonprofit sponsors and lenders in federal low-income housing tax credit transactions and HUD financings.
