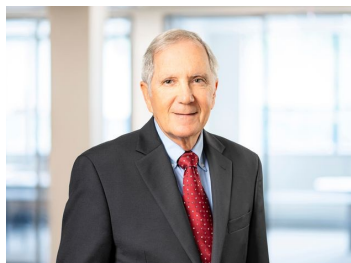
Directors of the Hispanic Family Center of Southern New Jersey, a nonprofit provider of social services. He lives in Cherry Hill.

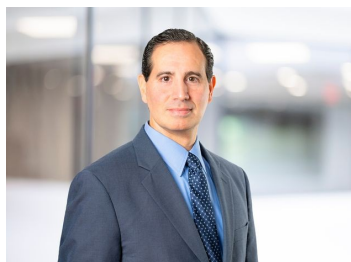
