

## Thomas Muccifori to Moderate Seminar Featuring Presiding Chancery Judges

Thomas A. Muccifori, co-Chair of the Burlington County Bar Association's General Equity Section, will help lead a continuing legal education (CLE) seminar entitled *Demystifying Chancery Practice*, presented by the Section on Jan. 25, 2011.

Mr. Muccifori, a shareholder of Archer, P.C., in Haddonfield, will serve as a moderator of the seminar at Aloft hotel in Mount Laurel, which features presiding chancery judges from central and southern New Jersey. They are:

- Hon. William C. Todd, P.J.Ch., Atlantic and Cape May Counties

These distinguished judges will discuss their particular general equity and probate practices and procedures, including Orders to Show Cause and emergent applications such as TROs and varying Preliminary Injunctions, plus tips for demystifying practice in the Chancery Division. This is a rare opportunity to hear from different chancellors about the varying particulars of chancery practice.

One topic that's certain to generate discussion is the increased scrutiny of mortgage foreclosure filings in the wake of disclosures of questionable paperwork submitted by lenders, including mass "robo-signings" of documents without proper verification of their accuracy. Judge Jacobson has been designated by New Jersey Supreme Court Chief Justice Stuart Rabner to oversee foreclosure matters in the state, while Judge Todd issued one of the leading decisions on the issue when he dismissed without prejudice a foreclosure complaint because the bank failed to prove it possessed the original note when it filed the case.
