The former County Counsel of Camden County, Mr. Mroz currently serves as legislative agent to the New Jersey Conference of Mayors.

He is also a member of the Board of Directors of the New Jersey Alliance for Action, a business and trade organization.

Mr. Mroz was appointed by President George W. Bush to the Commission on White House Fellowships, a group of highly accomplished citizens from across the country with a broad range of backgrounds, interests and professions. The commission recommends exceptional men and women to the President for White House Fellowships, the nation's most prestigious leadership development program, founded in 1965.

Active in political affairs, Mr. Mroz served during the 2008 New Jersey gubernatorial campaign as a policy advisor and attorney coordinating Election Day operations for the campaign of Chris Christie, who was elected Governor of New Jersey.

Additionally, Mr. Mroz served as statewide coordinator for the McCain 2008 New Jersey Campaign. Previously, he served as Counsel to the Bush-Cheney 2004 New Jersey Campaign Committee and as Special Counsel to the New Jersey Republican State Committee. In 2000, Mr. Mroz was the New Jersey representative to Philadelphia 2000 (Philadelphia's Host Committee) for the National Republican Convention, and coordinated all of New Jersey's efforts to support the 2000 Convention, including numerous special events.
