



# Frances McElhill Receives United Way's Highest Honor – the Tocqueville Award

Also honored at the event was Kim Fremont Fortunato, Director of Campbell Soup Company’s Childhood Obesity and Hunger Initiative, with the Nathan Asbell, M.D., Humanitarian Award, in recognition of her work to advance the common good and make Camden County a better place to live and work. The award is named for Dr. Nathan Asbell, a prominent physician and former United Way board member renowned for his dedication to improving the Camden City community.

“Their work on behalf of United Way has created real, lasting change and far-reaching impact that promotes a healthy, vibrant community,” said Mike Moynihan, Executive Director of United Way Greater Philadelphia and Southern New Jersey (UWGPSNJ) in Camden County. Mr. Moynihan presented the awards along with UWGPSNJ Board of Directors member Mindy Holman, President and CEO of Holman Automotive Group.
