On Wednesday, January 23, 2013, prominent attorney David H. Marion of Archer P.C. will receive the 2013 Judge Learned Hand Award presented by the American Jewish Committee of Philadelphia & Southern New Jersey (AJC). This award recognizes outstanding members of the Philadelphia legal community who have distinguished themselves through professional achievement and dedicated community leadership.

The Judge Learned Hand Award was established in honor of the senior judge of the Unites States Court of Appeals for the Second Circuit from 1924 to 1951, widely admired as a dean among American jurists and famous for the extensive range of decisions he rendered. In selecting Mr. Marion for this award, the AJC nominating committee cited his lifelong commitment to the profession and his contributions to many of the organizations and institutions that enhance the quality of life in the Philadelphia area.


