"It means a lot," Mr. Connell said of the award, "especially given the caliber of the people who have won this award in the past. It's very humbling to receive this, and I'm deeply grateful to the community."

The Lion's Club solicits nominations from the community and facilitates selection of Haddonfield's Citizen of the Year, who is announced each year at the Mayor's Breakfast.
