From copyright and defamation to e-discovery and employee rights, the legal implications of the social media explosion are significant and serious, explain the authors of a recent social media edition of *New Jersey Lawyer* magazine, for which Archer's [John C. "Therefore, it is important to note that, while social media is a subject to which unique legal questions apply, it is also a catalyst for the evolution of more traditional legal questions as social media extends to and alters the nature of otherwise customary social and commercial interactions.

"So, sage practitioners beware: No matter the issue, social media is in play, and its legal effect is not to be trifled with or ignored."

The issue also includes articles by Archer attorneys Jason Cotter of the firm's Intellectual Property Practice Group and Laura Link of the Labor and Employment Law Department. Mr. Cotter explores the application of correlative Federal Trade Commission (FTC) guidelines on endorsements in social media advertising. Ms. Link reviews the reach of the decisions and guidance documents of the National Labor Relations Board (NLRB) in regulating employers may policing of their employees' social media use.
