Mr. Isele was honored by the NJSBA in 2009 with its Distinguished Legislative Service Award, and by the Health Law Section in 2013 with its Distinguished Service Award. Mr. Isele was also honored by Ryder University's Law and Justice Program in 2014 for his "Distinguished Contributions to Law and Justice."

Mr. Isele serves in leadership roles in several not-for-profit organizations. He is a member of the Board of LeadingAge New Jersey, and also a member of the Board of Central Jersey Legal Services, Inc. In past leadership roles, Mr. Isele was an officer of the National Association of State Ombudsman Programs, a past-President of the Board of the Princeton Senior Resource Center, and a Trustee of the New Jersey Hospice and Palliative Care Organization.

Prior to joining Archer & Greiner, Mr. Isele served as the New Jersey State Ombudsman for the Institutionalized Elderly, from 1998 to 2007.
