The Rutgers University-Camden Alumni Association (RUCAA) recently honored Archer attorney Jennie A. Owens with the Frank Fulbrook Award for Community Service. Frank Fulbrook was a community activist and volunteer for RUCAA, and was one of Camden County's most relentless civic activists, fighting for what he believed was in the best interests for Camden residents and businesses.
