



# Carlos Bollar Sworn in as President of the Hispanic National Bar Association

September 30, 2021 - Archer partner **Carlos M. Bollar** was sworn in as the 44<sup>th</sup> President of the Hispanic National Bar Association (HNBA) on Wednesday, September 29. The swearing in ceremony took place during the HNBA Annual Convention *Gala en la Sala*, held virtually this year.

Carlos has been a deeply committed member of the HNBA, serving in various Board positions over the years. He previously served as the HNBA's National Finance Director. Prior to that, he served as the Regional President for Region III. In 2018, the HNBA honored Carlos with the Latino Lawyer of the Year Award. In addition to his position on the HNBA's Executive Committee, Carlos is also the past president of the Hispanic Bar Association of New Jersey. Carlos serves on the Board of Trustees for the New Jersey State Bar Association.

The Hispanic National Bar Association is a nonprofit, nonpartisan, national membership organization that represents the interests of Hispanic legal professionals in the United States and its territories. The association is committed to advocacy on issues of importance to the 58 million people of Hispanic heritage living in the U.S.
