Interested students will apply during their first year of law school and will be chosen prior to the start of their second year. The scholarship would be used to relieve tuition costs for the second year and, if stated academic requirements are satisfied, their third year as well.

The recipient of the scholarship award will also have the opportunity to participate in Archer's Summer Associate Internship Program upon completion of their second year of law school. Archer's summer associates gain real-world experience working with firm attorneys, staff and clients. The program serves as the base from which entry-level attorneys are hired.
