Created in 2007 in honor of Judge Martin L. Judge Lihotz is serving her second term as a Trustee of the Burlington County Bar Association. She also serves the BCBA as Co-Chair of the Professionalism Committee and a member of the Diversity Leadership and Family Law Committees.

Judge Lihotz was also the recipient of the 2019 Serpentelli Award presented by the Family Law Section of the New Jersey State Bar Association, given to her in recognition of lifelong and extraordinary contributions to the development of family law in the state of New Jersey.

Judge Lihotz earned her J.D. from Villanova University School of Law and an L.L.M. (taxation) from New York University School of Law. She received her undergraduate degree from the University of Delaware.
