She played a lead role on Governor Phil Murphy's successful 2017 campaign, helping to raise more than \$14 million. She also worked for over a decade as a political strategist and fundraiser for Democratic candidates across the country before becoming the Democratic National Committee's LGBT Finance Director.

As Mayor, Fahl prioritized fiscal responsibility, public budget management, affordable housing and infrastructure improvements. She led Lambertville through the COVID-19 Pandemic, as well as Hurricane Ida, the largest natural disaster in the city's history. She also successfully gained the support of the New Jersey Department of Transportation enabling her to complete a critical large-scale infrastructure project along Route 29 that had languished for more than 19 years.

Fahl most recently served as Vice President of Governmental Affairs for Tonio Burgos and Associates, Inc's New Jersey office. While there, Fahl managed a diverse portfolio that included state and national leaders in the clean energy production, land-use development and insurance fields.

“This is an incredible opportunity to fully utilize my private sector and public sector experience to assist clients across numerous sectors in meeting their needs,” said Fahl. “I am eager to be a part of a large, experienced New Jersey-based firm that is expanding quickly and has the capacity to explore developing platforms while managing many high visibility issues and concerns that are of critical importance to their clients, the state and the region.”
