She was also the recipient of the 2019 Serpentelli Award presented by the Family Law Section of the New Jersey State Bar Association, given to her in recognition of lifelong and extraordinary contributions to the development of family law in the state of New Jersey.

Judge Lihotz earned her Masters of Law (L.L.M.) in taxation from New York University School of Law, her Juris Doctor (J.D.) from Villanova University School of Law and her undergraduate degree from the University of Delaware.
