The Margarita Echevarria Trailblazer Award, named after the HBA-NJ's first president, pays tribute to her courage and foresight as a trailblazer for New Jersey Hispanic lawyers. The award recognizes individuals who have dared to blaze new trails and break through glass ceilings to advance the cause of Hispanic lawyers, and help create opportunities for the Hispanic community as a whole.

Carlos has been a deeply committed member of the HBA-NJ and the Hispanic National Bar Association (HNBA), serving in various Board positions over the years. Carlos is a past president of the HBA-NJ. He is also the immediate past president of the HNBA. He previously served as the HNBA's National Finance Director. Prior to that, he served as the Regional President for Region III. Carlos is a past recipient of the HNBA's Latino Lawyer of the Year Award. Carlos also serves on the Board of Trustees for the New Jersey State Bar Association.

In his practice, Carlos represents clients in complex toxic tort, product liability and environmental litigation matters.
